



## SOFTWARE LICENSE AGREEMENT

Mobatec Modeller License Agreement and Limited Warranty

IMPORTANT - READ CAREFULLY:

MOBATEC B.V. IS WILLING TO LICENSE ITS MOBATEC MODELLER SOFTWARE TO YOU ONLY ON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS IN THE SOFTWARE LICENSE AGREEMENT BELOW. PLEASE READ THE TERMS CAREFULLY. BY DOWNLOADING, INSTALLING, OR USING THE SOFTWARE YOU REPRESENT THAT YOU HAVE READ, UNDERSTOOD, AND AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THE AGREEMENT. IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS, DO NOT DOWNLOAD, INSTALL, OR USE THE SOFTWARE.

This is a legal agreement between you (either an individual or a single legal entity such as a corporation) and Mobatec B.V. for the software product Mobatec Modeller, which includes computer software and may include DATA FILES such as Models and associated media, printed materials, License Key and "online" or electronic documentation ("SOFTWARE PRODUCT").

This SOFTWARE PRODUCT is protected by Dutch copyright laws and international copyright laws and treaty provisions as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed for evaluation and demonstration purposes only.

### 1. GRANT OF LICENSE.

This license agreement grants you the following rights:

Software Installation and Use. You may only install and use an unlimited number of copies of the SOFTWARE PRODUCT on computers physically residing at a single geographic location, provided that you maintain the copyright notice on all copies of the SOFTWARE PRODUCT.

### License Options

Your license to install and use the Software shall be in accordance with one or more of the following License Options:

- a. Evaluation License. The Trial version of the Software comes with the download and has certain restrictions: You can only open Demo models. You cannot store any model that you make, and the program will automatically close after 3 hours of use.

- b. Commercial License. You may install the Software on an unlimited number of computers or servers for use concurrently by a number of individuals up to the number of user licenses you have purchased. The Software may be used only (i) by your employees and contractors working for you, (ii) on computers that are owned or controlled by you, and (iii) for the Company's own internal business purposes.
- c. Educational License. The Software may only be used for internal, non-commercial purposes. Examples of non-commercial uses include academic research, personal experimentation, or teaching and educational purposes. Academic Purposes means in support of coursework at an accredited educational institution. Examples include a professor using the Software to teach a course, a student using the Software for a course, or a student using the Software for research toward an advanced degree. An Educational License of the Software may not be used for commercial, professional, commercial training, or other for-profit purposes, including consulting or research subsidized by a private or government enterprise. Research projects are typically considered commercial unless the simulation results are made publicly available. The User agrees that it shall not use, and shall not authorize nor accommodate any third party to use Mobatec Modeller or any part thereof for any commercial or for-profit purpose, under the penalty of a fine of 50.000,- EUR.

Reselling. You may not sell or resell the SOFTWARE PRODUCT or any DATA FILES licensed to you as part of the SOFTWARE PRODUCT.

Trademarks. This License Agreement does not grant you any rights in connection with any trademarks of Mobatec B.V.

Termination. Without prejudice to any other rights, Mobatec B.V. may terminate this License Agreement if you fail to comply with the terms and conditions of this Evaluation Software License Agreement. In such event, you must return all copies of the SOFTWARE PRODUCT to Mobatec B.V.
